THE BOND SHALL BE USED TO (I) REFINANCE EXISTING DEBT OF THE BORROWER WITH THE BANK, (II) REFINANCE THE PURCHASE OF REAL PROPERTY TO BE USED AS A PARKING LOT, (III) FINANCE THE CONSTRUCTION OF A PARKING GARAGE, (IV) FINANCE THE CONSTRUCTION OF A PARKING LOT AND (V) FINANCE CONSTRUCTION AND RENOVATIONS RELATED TO THE BORROWER'S MAIN FACILITY.
