Education: In FY17, CMA's website www.SeeWinter.com generated 20,175,659 page views of animal and education pages, and our Facebook animal and educational videos generated 17,840,800 views.

As part of our nonprofit mission, hundreds of thousands of people visited CMA and were educated about marine life and conservation issues via presentations, videos, lectures and discussions.

The Education Department reached approximately 12,261 students who attended CMA's educational programs. These included seasonal camps, group add-on programs, floating classrooms, and sleepover programs. All

Animal Care: In 2017, the Marine Mammal department had several noteworthy events. Our resident non-releasable Great white pelican, Ricky, moved into the newly constructed aviary in May. In July, Skylar, a 9-year-old Great white pelican, joined Ricky, and in December, Matthew and Tyndall, age 4, completed our flock of Great white pelicans housed at CMA as these birds were brought to CMA as their facilities could no longer care for them. Walle and Cooper were the subject of a presentation given to our industry peers about the husbandry training work we do with rescued otters. Our rescued non-releasable dolphins, Nicholas, Winter and Hope, continued to meet and inspire our many special guests that visited the aquarium this year.

Inspiration: Through the Dolphin Tale major motion pictures, released in 42 countries, combined with years of media coverage, Winter the dolphin's overcoming story has reached and inspired millions of people all over the world. Wounded soldiers and children battling life-threatening conditions particularly connect with Winter and her tale of triumph, with many contacting and visiting CMA to complete the inspiration. Every year, CMA donates approximately 1,500 general admission tickets to host special needs groups and individual families at the Aquarium. Through our partnerships with nearly 40 different wish-granting organizations, hospitals, and family foundations, CMA has provided and continues to provide life-changing experiences to hundreds of

The funds are held by a third-party trustee and therefore the Aquarium has no direct influence over the investment policy of either fund. The Aquarium classifies as permanently restricted net assets the original value of the gifts donated to the permanent endowments. As required by GAAP, net assets associated with endowment funds are classified and reported based on the existence or absence of donor-imposed restrictions. The Aquarium's policy is to appropriate interest and dividends received from these endowments for operations. Therefore, interest and dividends is reported as unrestricted

on the Statements of Activities.

The Board of Directors of the Aquarium has interpreted the Florida Uniform Prudent Management of Institutional Funds Act ("FUPMIFA") as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the Aquarium classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. All permanently restricted net assets consist of perpetual trusts held by third parties. For all endowment funds, the donor's have stipulated that additional accumulation of funds above and beyond the permanent endowment are unrestricted as to purpose, however the Aquarium reports the accumulation of funds as temporarily restricted net assets until the funds are distributed by the trustees to the Aquarium and appropriated by the Board of Directors.

During FY 2017, CMA responded to a total of 2,541 animal emergency calls. CMA's rescue team responded to 14 cetacean events, representing four unique species in the Gulf of Mexico. Of these events, four responses were live animals including CMA-Pe-1708, a juvenile male Melon headed whale stranded on Treasure Island on June 4th, 2017. Additionally, the rescue team assisted the University of Florida in responding to a ten pilot whale mass stranding event in Perry Florida in July 2017. The rescue team has continued supporting manatee rescue operations via collaboration with FWC, aiding in the rescue, transport or relocation, and carcass recovery of over forty manatees. The team also provided short-term, stabilizing care for two river otter kits. The team continues to pursue the aquarium's mission through responding to and assisting in marine mammal stranding response.

The sea turtle department was busy in FY2017. Our 10 resident non-releasable sea turtles acclimated to their new homes and new companions. This included the addition of 6 (Harold, Madam, Cupid, Ula, Titus, Stubby) sea turtles to our renovated larger habitat, Mavis's Rescue Hideaway, where these turtles co-exist amongst a naturalistic setting.

The rehabilitation efforts continued with a total of 2,147 calls. Of those calls there were a total of 155 sea turtle responses resulting in 80 live intakes. Ultimately, 48 sea turtles successfully underwent rehabilitation and were released back out into their natural habitat as
